In accordance with my Internal Audit Plan, Controls and Procedures have been tested, with Fraud and Risk Issues reviewed - these are well managed, in line with the Local Councils Practitioners' Guides and meet the needs of the Council. I confirm that I do not have any role within the Council and will carry out my duties without bias. I would only comment by exception - the following points are for the attention of the Council:

1. Internal Financial Regulations - these were taken from a NALC Template. Section 5.1 states that Credit References should be taken on new Signatories to the Bank Accounts. This could prove unacceptable by some Councillors and might be removed. Many Banks automatically take Credit References on new Signatories, but do not pass on the Results to their Customers.
2. Insurance - Council Assets. There have been a few items acquired during the year - it is recommended that they are added to the Schedule.
